

Financial Assistance for Older Adults

There are many support services available for older adults through the City of Mississauga, Region of Peel, Province of Ontario and the Government of Canada. This document provides an overview of financial assistance programs available, where to find more information and how to check if you are eligible.

Details are subject to change, so residents are advised to check the respective websites for up-to-date information.

Property

Property Tax Rebate for Low-Income Seniors and Low-Income Persons with Disabilities Program (CITY)

An annual property tax rebate of \$601 (2026 rate) for low-income seniors and disabled homeowners, who receive Guaranteed Income Supplement (GIS) or benefits under the Ontario Disability Support Program (ODSP).

Stormwater Subsidy Program (CITY)

An additional subsidy that helps pay for 100 per cent of the stormwater charge for recipients of the Low-Income Seniors and Low-Income Persons with Disabilities Property Tax Rebate Program.

HOW TO APPLY

You automatically qualify for this subsidy if you qualify for the property tax rebate mentioned to the left. A separate application is not required.

Outdoor Maintenance Subsidy for Residents with Low Income (CITY)

Financial assistance of up to \$400 (2024 rates) to help recoup the costs of outdoor maintenance services (lawn care, trees, snow removal, etc.) for eligible seniors with low incomes and people with disabilities with low incomes. An owner, spouse of an owner, or a tenant of a property who receives the Guaranteed Income Supplement (GIS) or benefits under the Ontario Disability Support Program (ODSP) may be eligible for the subsidy for a property if it is their primary residence and there is no one over the age of 16 who lives at the property that can perform outdoor maintenance services. As well, the property must not be an apartment or condominium where outdoor maintenance is handled by building management.

Applications are due by March 31 of the following year for services you paid between January and December of the previous year.

Ontario Trillium Benefit (PROVINCIAL)

A group of three tax credits to help offset energy costs, as well as sales and property tax. Applicants can receive annually up to \$285 for the Northern Ontario Energy Credit, up to \$1,461 for the Ontario Energy and Property Tax Credit, and up to \$371 for the Ontario Sales Tax Credit.

Low-Income Energy Assistance Program (LEAP) (PROVINCIAL)

Emergency financial assistance for low-income residents to help pay for gas and electricity bills. You could receive up to \$780 for electricity bills and up to \$650 for gas.

Ontario Seniors Homeowners’ Property Tax Grant (PROVINCIAL)

A grant for up to \$500 annually to help low-to-moderate income seniors with the cost of your property taxes, when you own and occupy your home in Ontario.

HOW TO APPLY

MPAC Senior or Disabled Property Tax Relief (PROVINCIAL)

A tax exemption provided for a portion of residential property that has been modified or custom-built to accommodate a senior or a person with a disability. This may include renovations or modifications made to an existing residential home, the construction of a custom-built home or the use of a temporary garden suite with a property-specific by-law or order under the *Planning Act*. If approved, a portion of the property's assessment value will be exempt from property tax.

Home and Vehicle Modification Program (PROVINCIAL)

Financial assistance is available to help cover basic home and vehicle modifications for eligible individuals and families. This support ensures that children and adults with disabilities can live safely at home, keep their jobs, and stay active in their communities.

You can receive up to \$15,000 per lifetime for home modifications, adaptations and devices, and up to \$15,000 every 10 years for vehicle modifications.

Recreation

ActiveAssist Program (CITY)

An annual, non-refundable credit of up to \$275 per eligible family member for low-income residents and refugees to help access recreation and culture programs. In order to qualify, your income must be below the Low Income Cut Off amounts as published by Statistics Canada based on your family size. Applicants must reapply and provide supporting documents on an annual basis.

65+ Fit membership

Mississauga residents aged 65 and older can take advantage of the City's free Older Adult Twelve Month (65+) Membership, offering year round, no cost access to City recreation and leisure facilities. This membership supports active, healthy living by providing opportunities to participate in a variety of programs and activities at local community centres, helping older adults stay engaged, connected, and well in their community—without financial barriers. Apply in person at any City of Mississauga community centre with ID and proof of residency.

Transit

MiWay Senior Discount Fares (CITY)

Seniors ages 65 and older can ride MiWay for free with a PRESTO card set to the senior fare type. The PRESTO card must be purchased for a one-time fee of \$4 and does not expire. PRESTO cards that are not set to a specific fare type will be charged the Adult PRESTO single fare \$3.50 or cash fare \$4.50.

HOW TO APPLY

Seniors can set the fare type on their PRESTO card by [visiting a customer service outlet](#) and showing proof of age. The free fare will be automatically applied when you tap on MiWay buses.

Affordable Transit Program

(CITY AND REGION)

This program is offered in partnership between MiWay and Peel Region. Eligible Peel residents can apply for a 50% annual discount on MiWay PRESTO adult monthly pass or single fare.

To continue receiving the discount after 12 months, you must reapply through Peel Region.

Ontario Seniors' Public Transit Tax Credit (PROVINCIAL)

A refundable tax credit to help seniors with public transit costs. You can claim up to \$3,000 in travel expenses to receive a credit of up to \$450 annually. Services that qualify include the fare you pay on eligible Ontario or municipally-operated public transit services, including transit services provided by Metrolinx and services that run from within Ontario to a destination outside Ontario.

Long-haul and private-sector services, such as Via Rail, FlixBus and ride-hailing services, aren't eligible. Save your receipts and proofs of payment to submit your claim. You must be 65 years of age or older on December 31 of the previous tax year, and a resident of Ontario on December 31 of the tax year you are claiming for.

HOW TO APPLY

Claim when you file your personal income tax return and ensure that you keep all receipts from your travel.

Income Supports

Guaranteed Annual Income System (GAINS) (PROVINCIAL)

A non-taxable monthly payment of up to \$90 to ensure a guaranteed minimum income for qualifying Ontario senior pensioners with low income. Qualification and payment amounts depend on your age and marital status.

HOW TO APPLY

If you currently receive the OAS pension and GIS, you do not have to apply.

Your GAINS payment will be determined based on information received from Employment and Social Development Canada and the details provided on your personal income tax return. Ensure that you file your income taxes every year by April 30, even if you do not have income to report or complete a GIS application and send to your nearest Service Canada office.

Old Age Security (OAS) (FEDERAL) and Guaranteed Income Supplement (GIS)

A monthly, non-taxable benefit of up to \$814.10 is available to most Canadian seniors, with an additional non-taxable payment of up to \$1105.43 available for low-income seniors. How much you receive is based on your age, income, and marital status.

HOW TO APPLY

Some residents are automatically considered for both payments when you turn 65 and file your tax return. Service Canada will inform you if you have been automatically enrolled.

Otherwise, you may need to submit an application **online** through the My Service Canada Account at canada.ca and **search** My Service Account (MCSA) or
Submit your form at a Service Canada Office.

Survivor Allowance (FEDERAL)

A monthly benefit of up to \$1675.45 for low-income residents age 60-64, who reside in Canada, and whose spouse or common-law partner has died, and you have not remarried or entered into another common-law partnership. Your annual income must also be less than \$30,216 which is the current maximum annual income threshold for the Allowance for the Survivor.

Dental

Ontario Seniors Dental Care Plan (OSDCP) (PROVINCIAL)

A government-funded dental care program to provide free, routine dental care services for eligible, low-income seniors age 65+. Once you are enrolled in the program, your coverage period is for up to one year. Coverage ends on July 31 every year, no matter when you enroll. Once enrolled, eligibility will be automatically verified for most clients to confirm enrollment for the next benefit period. Otherwise, you will be notified by mail if you need to reapply.

Canada Dental Care Plan (CDCP) (FEDERAL)

A government-funded dental insurance program to provide coverage for a range of dental services for eligible Canadian residents. Your dentist must also opt into the program for you to access coverage.

Note: You cannot coordinate benefits between the OSDCP and CDCP. You must pick one to submit your dental care claim.

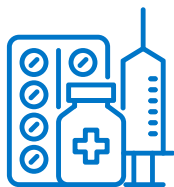

Other Health Supports

Ontario Drug Benefit (PROVINCIAL)

A program to help cover most of the cost of prescription drug products for seniors. Enrollment is automatic for eligible seniors as of your 65th birthday and you should receive a letter three months in advance. Residents may also qualify to apply for a reduced co-payment if your annual income is less than \$25,000. As a senior, you pay a portion of prescription drug costs based on your annual income and marital status.

Disabilities Support

Note: Each program assesses eligible disabilities separately. Qualifying for one program does not guarantee qualification for the other.

Ontario Disability Support Program (ODSP)

(PROVINCIAL)

Monthly financial assistance of up to \$1,408 for eligible Ontarians living with disabilities to help with essential living expenses. Payments are indexed to inflation and increase annually.

Assistive Devices Program

(PROVINCIAL)

A benefit to help cover up to 75 per cent of the cost of customized equipment, such as wheelchairs and hearing aids, for people with long-term physical disabilities. The program is applied at the point of sale.

Applicants must have a valid Ontario Health Card and a disability that requires the use of support devices for at least six months and meet clinical criteria specific to the device you are applying for. Income is not considered for this benefit.

Disability Tax Credit

(FEDERAL)

A non-refundable tax credit for eligible individuals living with disabilities and their qualifying family members who provide care or support. The amount is indexed to inflation and increases each year. You must have a medical practitioner certify your condition to qualify.
