

# THE CORPORATION OF THE CITY OF MISSISSAUGA BY-LAW NUMBER 02 3-2023

A by-law to amend By-law Number 0225-2007, as amended.

WHEREAS pursuant to section 34 of the *Planning Act*, R.S.O. 1990, c.P.13, as amended, the council of a local municipality may pass a zoning by-law;

NOW THEREFORE the Council of The Corporation of the City of Mississauga ENACTS as follows:

- 1. By-law Number 0225-2007, as amended, being a City of Mississauga Zoning By-law, is amended by deleting Exception Table 6.2.2.17.
- 2. By-law Number 0225-2007, as amended, is further amended by deleting Exception Table 6.2.2.22.

means a temporary, outdoor seating area, located on a parking space or sidewalk which may be covered only by a temporary tent, and is operated as accessory to a restaurant, convenience restaurant or take-out restaurant.









































# APPENDIX "A" TO BY-LAW NUMBER 0217-2023

## Explanation of the Purpose and Effect of the By-law

The purpose of this By-law is to update the temporary use zoning permissions for both temporary outdoor patios and temporary outdoor retail sales and displays to as-of-right uses within certain Base and Exception Zones, including the Port Credit Business Improvement Association (BIA). In addition, this by-law amendment will also add new permissions for permanent outdoor patios, add new zone permissions for the use of temporary tents, remove the minimum separation distance requirement for restaurants, convenience restaurants and take-out restaurants adjacent to Residential Zones and remove references to the aforementioned deleted separation distances.

Amendments include revisions to the following parts of the Zoning By-law:

- RA2 Exception Zones
- RA4 Exception Zones
- RA5 Exception Zones
