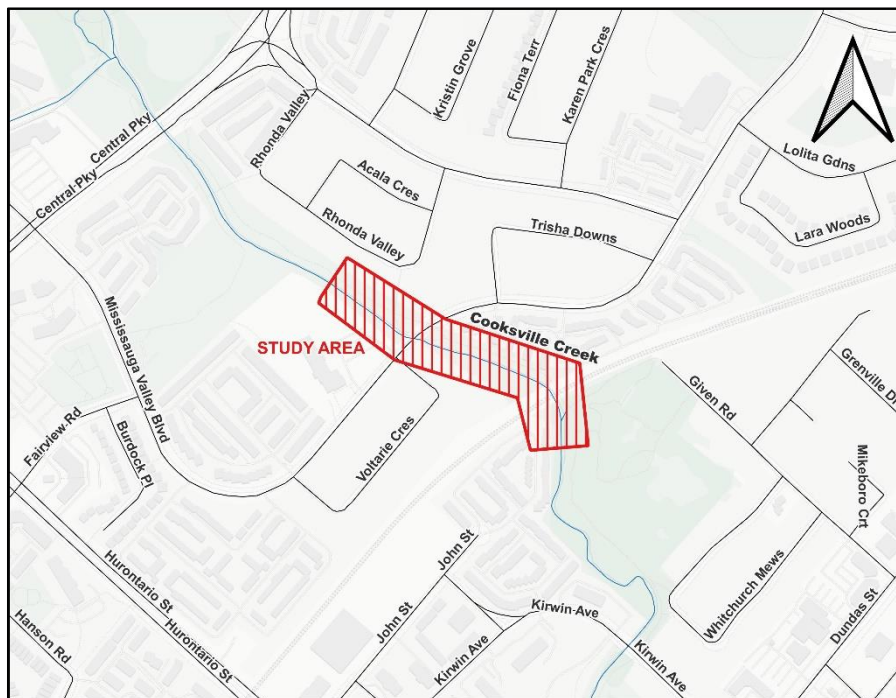


NOTICE OF STUDY COMPLETION
Cooksville Creek Erosion Control Project
Class Environmental Assessment
Issued April 12, 2024

The Study

The City of Mississauga, through their consultant Matrix Solutions Inc., has completed a Class Environmental Assessment to address erosion concerns for Cooksville Creek, from Mississauga Valley Blvd to CP Railway of Mississauga. Through its ongoing erosion monitoring program, the City of Mississauga recognized that this section of Cooksville Creek needs rehabilitation to address existing erosion issues, failing bank protection, and to provide an opportunity to naturalize the site. The map below shows the location of the study area. The project was conducted under *Schedule "B"* in accordance with the requirements of the *Class Environmental Assessment for Municipal Projects*.



Study Completion

The Project File Report (PFR) has been completed and by this Notice is being placed in the public record for review. Subject to comments received as a result of this Notice, and the receipt of necessary approvals, the City of Mississauga intends to proceed with the design and construction of this project.

Consultation is an important part of the Municipal Class Environmental Assessment process, and we want to hear from you. The PFR will be available for a 30- day comment period starting on April 12, 2024 and ending on May 12, 2024. The Project File Report is available for review on the City’s project website:
