## THE CORPORATION OF THE CITY OF MISSISSAUGA

### By-law 0222-2022

A by-law to repeal By-law 0206-2018 and to appoint an Acting Head of Council for The Corporation of the City of Mississauga

(Amended by By-law 0022-2024, 0044-2022 s.94(3)(d))

**WHEREAS** Section 242 of the *Municipal Act*, 2001, S.O. 2001, c.25, as amended, provides for the appointment of a member of Council to act in the place of the head of Council, when the head of Council is absent, refuses to act or the office is vacant;

**AND WHEREAS** the Council of The Corporation of the City of Mississauga enacted By-law No. 0206-2018 to appoint an acting head of Council for the Corporation;

**AND WHEREAS** Council now deems it expedient to repeal By-law No. 0206-2018 and to appoint an acting head to coincide with and reflect the current term of Council;

**NOW THEREFORE**, the Council of The Corporation of the City of Mississauga **ENACTS** as follows:

1. That By-law No. 0206-2018 is repealed effective immediately.
2. That the Member of the Council representing the Ward in Column 1 below is appointed as acting head of Council of The Corporation of the City of Mississauga (the "Corporation") if, at any time during the months shown opposite their respective ward in Column 2 below, the head of Council is absent, refuses to act, or the office is vacant:

3. If a Member of Council is absent for any reason at any time or times in the months during which that Member is appointed as acting head of Council of the Corporation under Section 2 of this By-Law, the Member of Council representing the ward that immediately follows the ward of the absent Member in Column 1 of Section 2, is appointed to act in that Member's place.
4. Members of Council shall sign and submit to the City Clerk a declaration that they do not intend to be a candidate in an upcoming municipal by-election or in a provincial or federal election or by-election prior to commencing their appointment as acting head of Council of the Corporation under section 2 of this By-law. (0022-2024)
5. If a Member of Council is a candidate or has expressed their intention to be a candidate in a municipal by-election or a provincial or federal election or by-election, that Member of Council shall forfeit their appointment as acting head of Council of the Corporation under section 2 of this By-law, effective: (0022-2024)
  - a) when a mayoral vacancy is declared until after the last day of voting in a municipal by-election; and
  - b) on the day the writ for an election is issued or a by-election is called until after the last day of voting in a provincial or federal election or by-election.
6. If a Member of Council forfeits their appointment as acting head of Council of the Corporation pursuant to section 5 of this By-law, the schedule will be adjusted such that the remaining Members of Council will continue to be appointed as acting head of Council for the period of time established and in the rotation set out in section 2 of this By-law. (0022-2024)
