Section 1: Rebate Details

The Basement Flooding Prevention Program provides a rebate of up to \$7,500 to support residents with the installation of eligible basement flooding prevention measures.

Section 2: Eligible Prevention Measures

Homeowner is to undertake their due diligence with qualified contractors to investigate and determine suitable prevention measure for their home. The City does not guarantee or warrant the quality of workmanship or the suitability of any or all of the Work to be completed on the property.

Notes:

- sump pump installations must connect foundation drain (weeping tile) to sump pit and disconnect storm lateral (capping) and downspouts
- costs may include eligible contractor labour, material and taxes and consulting or inspection costs to determine appropriate measures
- Unused rebate amounts from one basement prevention measure cannot be used to cover the cost of another measure.
- disconnected downspouts should discharge a minimum of 4-6 feet away from foundation to lawn/garden or to rain barrel, etc.
- prevention measures may not be appropriate for non-standard foundation drain connections. Foundation drain connections to sanitary sewer require consultation with Region of Peel and contractor to discuss appropriate measures before application.

Terms & Conditions - READ CAREFULLY

In consideration of applying for and receiving a rebate under the Basement Flood Prevention Rebate Program (the "Program") from the City of Mississauga ("the City"), the Owner acknowledges and agrees to the following:

- 1. Only one registered owner per residential address is eligible to receive a rebate.
- 2. City staff will not review or discuss Owner's application and status with any contractors.
- 3. Sump pump installations required for new/infill development are not eligible for this rebate.
- 4. Residential dwelling must not have received a basement flooding prevention rebate or similar in the last 10 years. A replacement sump pump or backwater valve rebate application may be made after 10 years from previous application approved date.
- 5. The City reserves the right to cancel, suspend, or alter the Program at any time.
- 6. The City reserves the right to inspect an applicant's residential dwelling upon reasonable notice to the applicant to verify the information provided in support of the application. Where access for such an inspection is denied by the applicant, the City reserves the right to deny the application.

- 7. The Owner must ensure that water discharged from sump pumps and downspouts does not negatively impact neighbouring private properties, public properties including schools and parks, municipal right-of-ways, and must not discharge directly to watercourses.
- 8. The City may deny an application for a rebate if it determines that any of the information contained in an application is untrue.
- 9. Work is defined as the installation of eligible prevention measures and related works by a Contractor.
- 10. Completed Work is defined as Work which is fully functional and acceptable under industry standards. Work is only deemed 'Complete' when the receipt for the full cost of the Completed Work and/or building permit sign off is provided to the City.
- 11. Contractor is defined as an individual qualified to perform the work who holds a valid City of Mississauga business license, as applicable, retained by the Owner to complete the required Work on the property.
- 12. Original copies of invoice(s) for the full cost paid of measures must be provided and show the address of the eligible installation, name and licence number of the Contractor, a cost breakdown of all charges and must indicate payment in full by the Contractor to the satisfaction of the City.
- 13. Any and all costs for the Work, not covered by the Program, shall be at the Owner's sole cost and expense.
- 14. The Owner, not the City, is responsible for the on-going operation and maintenance of all equipment installed as part of the Work and shall notify any subsequent owners upon the sale of the property of the owner's maintenance obligations.
- 15. City may hire a consultant to represent the City for the purpose of evaluating and administrating this Program.
- 16. Reimbursement will not be provided for replacing interior finishes, such as drywall, paint or flooring.

- 17. Reimbursement will not be provided for exterior restoration, such as landscaping, gardening, sod, trees, shrubs, porches, decks, concrete or asphalt.
- 18. Reimbursement will not be provided for weeping tile replacement/repair, other basement waterproofing measures/services, secondary or back-up sump pumps, additional generators or other back-up power not included with initial install.
- 19. Labour provided by the Owner, to reduce Contractor costs, will not be eligible for reimbursement under the Program.
- 20. The City's decision to rebate, in whole or in part, any portion of the Work shall not be considered in any way an admission on the part of the City of liability or responsibility for past or future basement water infiltration occurrences.
- 21. The City does not guarantee or warrant the quality of workmanship or the suitability of any or all of the Work to be completed on the property or that the performance of any or all of the parts/products used to complete the Work will be free of defects.
- 22. The Owner shall indemnify and hold harmless the City and their respective representatives against all liability, loss, costs, claims, damages, and expenses causes of action, actions, claims, demands, lawsuits and other proceedings, by whomever made, sustained, brought or prosecuted, including third party bodily injury, death, personal injury, and property damage, in any way based upon, occasioned by or attributable to the Owner's participation in this Program or as a result of the Work performed by the Contractor.
- 23. The final decision to approve or deny a rebate application rests with the Commissioner of Transportation & Works, and is not subject to review or appeal.
- 24. Personal information and supporting documentation is collected under the authority of the Municipal Act, 2001 and is subject to disclosure under the terms of the Municipal Freedom of Information and Protection of Privacy Act. This information will be used to determine eligibility requirements for the rebate program.
