- Proof of standard liability insurance with a per occurrence limit of at least \$2,000,000, this could be a letter from your insurance company or a copy of your insurance policy.
- Evidence that the rental is your principal residence. This could be a recent utility bill or tax form issued in the last 12 months.
- Proof of property ownership this could be a copy of property tax bill or MPAC notice of assessment (if owner).
- A letter of authorization from property owner (if renting).
- Proof from condominium corporation that short-term accommodations are permitted.
- Once all required items have been received and reviewed, a Municipal Law Enforcement Officer will
 contact you to schedule an inspection of your rental to make sure it meets all City standards, before a
 licence is issued.
