
The Small Arms Inspection Building is a historic, multipurpose building that hosts a wide range of arts and cultural programs and provides rental space for cultural organizations and the community.

### Location

1352 Lakeshore Rd. E

Small Arms Inspection Building is located on Lakeshore Road East, near the border between Mississauga and Etobicoke. It's conveniently located on the MiWay 5 Dixie and 23 Lakeshore bus routes and a short walk from the Long Branch GO Station.

### **Public Transit**

Easily accessible by Mississauga public transit routes and a 10-minute walk from the Long Branch GO Station on the eastern border of the Mississauga Waterfront.

### **Accessibility**

Small Arms Inspection Building has a ground-level entrance with automatic doors. There are accessible, single-user, all-gender washrooms with baby changing stations available inside the building.

### **Parking**

Free parking is available on the east side of the building. The parking lot can accommodate up to 160 vehicles with nine spots designated for accessible parking.

Bike racks are available outside of the main entrance.





### **South Space**

The historic Small Arms Inspection Building features industrial architecture that is lined with high windows and a central skylight that illuminate the space. The space offers the flexibility for many uses, including exhibitions, musical performances, theatre productions, rehearsals, weddings, conferences and festivals.

#### **Dimensions**

18,000 square foot, open-concept space, including a 3,000 square foot outdoor courtyard

### **Room Capacities**

Up to 400 standing, seated rounds, theatre style or classroom set up

### **Ceiling Height**

10 ft to pendants lights13 ft to exposed white beams14 feet to ceiling



Onsite event coordinators and building operations staff are mandatory for all events from the beginning of load-in to the end of load-out.



## **Arts/Cultural/Heritage Events**

Activities identified as Cultural Activites that support Creative Entrepreneurs as defined in our annual fees & charges bylaw are eligible for a 25% discount.

## **Deposit Requirements & Contract Execution**

All arrangements for rentals are considered to be tentative until a contract has been signed. The event is considered firm when the deposit has been received along with a pre authorized credit card or post dated cheque for the remaining balance. All payments are due prior to the event.

### **Insurance Requirements**

General liability insurance is required for all events at Small Arms Inspection Building. The following insurance requirements must be met for all events at the SAIB:

- \$5 million general liability insurance
- Name "The Corporation of the City of Mississauga" as an additional insured
- Cover all event dates including set-up and clean-up
- Proof of Insurance will only be accepted on the City of Mississauga template
- Must be signed, dated, and stamped by the insurance provider or broker





### **Vendor Types**

All special event vendors are either commercial or display vendors and either food or non-food vendors.

**Commercial vendor:** Vendor who sells or displays for sale any goods, foods, or services

**Display vendor:** Vendor who is not selling or displaying for sale any good, foods or services (can include sponsors, info booths, free games, free food)

Food vendor: Vendor that serves or

sells food

Non-food vendor: Vendor that does not

serve or sell food

### **Mobile Licensing**

Event Organizers require a Special Event License when an event includes vendors selling any service or product outdoors, when sales proceeds are being donated, when a service or product is being given out for free but is paid for by the event organizer or other **involved** party.

To obtain a license for a special event read and complete the Special Event License Application Form & Event Organizer Participation Agreement. For more information on how to obtain a license for a special event, read the Licences and Permits webpage and complete the application form.

### **Region of Peel Health Department**

If an event will be selling or distributing food, Peel Public Health requires notification. Event organizers must complete a <u>Special Event Application</u> for Event Organizers a minimum of 30 days prior to the event. A Public Health Inspector will contact event organizers and vendors to review information on the forms, and obtain additional required information prior to issuing written notice to event organizers. A Public Health Inspector may also conduct inspections during the event.



## Safety & Security

### **Health and Safety**

As required by the City of Mississauga and provincial regulations, employers and workers are required to comply with fire, health and safety regulations. The following section outlines specific health and safety requirements for SAIB.

### **Alcohol**

A Special Occasion Permit (SOP) is needed any time alcohol is sold or served anywhere other than in a licensed establishment or a private place. A Special Occasion Permit holder is responsible for the safety and sobriety of people attending the event, as well as compliance with the Liquor Licence Act and Regulations. Events that are open to the public whereby alcohol is being served require security personnel in addition to a safety plan that the event organizer must share with the Culture Coordinator in advance of the event.

### **Vehicles**

Vehicles are not permitted to be driven inside the building. Vehicles are permitted to park at the South Loading dock during designated load-in and load-out times only. Vehicles are not permitted to park in the east courtyard with the exception of food trucks, display vehicles or vehicles necessary for reasons of food safety during events.

### Weather

Outdoor events are by their nature subject to inclement weather. In the case of rain, an event can continue provided that it is deemed safe by the Manager on Call for the Small Arms Inspection Building. In the case of lightning, the Onsite Event Coordinator is required to shut down the event to reduce the risk of a lightning strike in accordance with the Outdoor Venues Safety Guideline for the Live Performance Industry in Ontario.
