

# **CALL TO ARTISTS – Expressions of Interest (EOI)**

### **Permanent Public Art for Zonta Meadows Park**

Submission deadline: October 8, 2025 by 11:59PM EST

**Budget: \$310,000 CAD + HST** 

The City of Mississauga (the "City") seeks to commission an artist or artist team to create permanent public art for Zonta Meadows, an urban park located in the city's Downtown Core. The City seeks innovative artwork that encourages walkability, social connection, and community wellbeing.

This is a two-stage artist selection process. Up to three artists will be shortlisted from this call to develop a proposal. The deadline to submit Expressions of Interest for this opportunity is Wednesday, October 8, 2025, by 11:59 p.m.

The budget for this artwork is \$ 310,000.00 + HST Canadian Dollars. The City aims to install and unveil the artwork in late fall 2026 or early 2027.

# 1. Eligibility

This is a public competition open to professional artists and artist/artist-led teams\*.

\* The City of Mississauga defines a professional artist as an individual who earns all or a sizable portion of their livelihood through remuneration for artistic performance or creation and is recognized by their peers as an artist.

#### **Juried Submission**

- ☐ Artist expression of interest: describe your artistic practice and why you are interested in this opportunity.
  - You can submit a written statement (1000 word maximum) or a recorded video (an MP4 file or online link, max 20 MB).
- Artist CV
- ☐ Artist portfolio: submit up to 10 images of past work, highlighting work that showcases your style, approach and interests.
  - Each image should include: title, year, media, location, project budget, dimensions, collaborators and/or commissioning agencies
  - Tip: We recommend creating a 10-slide PowerPoint presentation, in which each image includes the required descriptive text. Once the presentation is complete, you can export it as Image Files and use these files to upload your portfolio.

# 3. Project Brief

The lands that constitute the present-day City of Mississauga are part of the Treaty and Traditional Territory of the Mississaugas of the Credit First Nation and the territory of the Anishinaabe, Seneca, Haudenosaunee and Huron-Wendat people.

Funded by Amacon as part of their <u>Parkside Village</u> development, <u>Zonta Meadows Park</u> (410 Rathburn Rd W) is an urban and family-oriented park located in Mississauga's Downtown Core. The public artwork will be located in an expanded section of the park that is bordered by Wallenburg Crescent on the south and Parkside Village Drive on the east. The design of this section is inspired by Canadian heritage and incorporates symbols of maple trees and foliage. For example, the shade structures have leaf motifs, along with an area of the park that includes a red maple leaf engraved into the concrete pavement. The expanded park will include new amenities including pickleball, tennis, and basketball courts; a skatepark and pump track; a



soccer field; an off-leash dog park; play areas; open green space; a cherry blossom grove; a community garden; and more.

The standalone artwork will be located within a gathering space on the east side of the park: a circular paved area with benches around the perimeter. There are spring blossom trees surrounding the area and multiple access points, including two walkways from inside the park and connections to the sidewalk on Parkside Village Drive. The arrow on the concept plan for Zonta Meadows Park (below) indicates the future public artwork's location:

To harmonize with the design and amenities of the park, the public artwork may engage themes of play, environment, natural habitat, animals, living heritage, local heritage or national identity and wellbeing. The City seeks to commission innovative artwork that encourages walkability, social connection, and community wellbeing.



Zonta Meadows Park connects residential single-family homes on the west side of the park, with downtown condominiums on the east side of the park. Downtown Mississauga is a dynamic, urban area located in the heart of the city with connections to the rest of the city, the Greater Toronto Area, and beyond. The Downtown Core consists of high-density residential developments, office buildings, mixed use developments, parks, post secondary institutional and cultural facilities, civic uses, and recreational and entertainment uses developed around the periphery of the Square One Shopping Centre.

### 4. Anticipated Budget

The total budget for all artist fees and expenses related to this project is \$ 300,000.00 + HST Canadian Dollars.\*

Up to three artists will be shortlisted from this call to develop a proposal. Separate from the total project budget, the proposal fee is \$3,000.00 CAD + HST. No further compensation will be made to the artist for costs associated with participating in the selection process.

\* This fee includes (but is not limited to): artist fees, technical consultation, travel to the site and project meetings, purchase of relevant materials, engineering fees (if applicable), fabrication and artwork installation (including delivery to the site), insurance and/or permit fees as required by the City of Mississauga, maintenance plan documentation, and attendance at unveiling of the completed artwork.

## 5. Anticipated Schedule

It is expected that the commissioned artist(s) will comply with the project's general timeline dates, as highlighted below:

#### 6. Selection Process and Criteria

An art selection jury comprised of arts professionals, community members and/or members of the project team will score proposals against an evaluation matrix.

The jury will recommend up to three (3) artists or artist teams to be invited to prepare design proposals for the site. The jury will evaluate applications for the next stage based on the following criteria:

- Artist's interest, approach, and expressed desire in this project, as expressed in the written expression of interest;
- Qualifications and professional experience of the artist, as evidenced in the resume/CV(s);
- Artistic excellence, merit, originality, skill and innovation, as evidenced in the samples of previous work; and
- Artist's demonstrated ability to successfully execute a project of this scale under the criteria developed and within the budget and timeline.

The City of Mississauga's public art program accepts informal training and community/peer recognition, and recognizes artists, creators, and storytellers from a diverse range of disciplines. Please do not hesitate to reach out to our team or send a submission, even if you are unsure if your credentials are suitable for the opportunity.

The City of Mississauga reserves the right to select and retain the artist deemed most appropriate for the project at its sole discretion.



## 7. Commitment to Equity

The City's Public Art Program is committed to continually improving our application processes to ensure equitable and inclusive opportunities for all. ### 8. Reserved Rights of the City of Mississauga

The City reserves the right, at its sole discretion, to determine the number of pre-qualified Artists or Artist Teams. The City reserves the right to not proceed with awarding a contract.

#### 9. Publication of Competition Information

The City of Mississauga shall have the exclusive right to issue all public announcements regarding the competition.
