

Candidate Voters' List Declaration

I _____ (*please print*), a candidate in the City of Mississauga's 2024 By-election, am requesting a copy of the voters' list under subsection 23(4) of the Municipal Elections Act, 1996 (the MEA). In accordance with subsections 23(7) and 23(8) of the MEA, I solemnly declare that:

1. I shall use the voters' list only for electoral purposes and shall not use it for commercial purposes.
2. I shall follow and be bound by the restrictions in the MEA, which have been provided to me for reference either hard copy (upon my request) or electronically.
3. I will only disclose the contents of the voters' list to another person after obtaining their written acknowledgement that they are bound by the restrictions in the MEA.
4. I understand that if I provide the contents of the voters' list to another person:
 - a. they shall not provide the voters' list to any other person, and will not make any further copies, either in printed form or electronically;
 - b. if they received a printed copy, they shall return it to me on or before July 25, 2024 or on or before the day my campaign period ends if my campaign ends before July 25, 2024; and
 - c. if they received an electronic copy, they shall destroy it, and shall provide me with a written acknowledgement of the destruction, on or before July 25, 2024 or on the day my campaign period ends if my campaign period ends before July 25, 2024.
5. If I do provide the voters' list to another person, I will retain the written acknowledgement provided by each person to whom I have provided the voters' list, which I am required to collect and retain for the term of office in accordance with subsection 23(8)5 of the MEA;
6. I shall, on or before the day my campaign period ends if my campaign ends before July 25, 2024 or on July 25, 2024:
 - a. destroy the part of the voters' list or return it to the Office of the City Clerk, 2nd Floor, 300 City Centre Drive ("Office of the City Clerk") for destruction;
 - b. destroy any printed copies returned to me from other persons or return it to the Office of the City Clerk for destruction; and
 - c. require the receipt of the written acknowledgements of destruction that are to be provided to me under subsection 4(c) above.

By signing this declaration, you are also acknowledging that in accordance with the MEA, you will receive a voter's list after nominations close in April 2024 and voters' lists updated to reflect those who voted following each Advance Poll Day only and you will not receive a final voters' list following the last voting day.

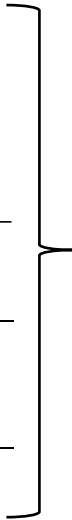
I make this declaration conscientiously believing it to be true and knowing that it is of the same force an effect as if made under oath (*to be signed in front of an election official at the time of your appointment*).
