### 5.0 Consent Agenda: Staff Information Reports

Discussion highlights are as follows:

The CEO informed the Board of the Service Hours changes starting in September.
 The changes will have library locations opening earlier adding 30 hours of service each week. In addition to Hazel McCallion Central Library, Burnhamthorpe, Malton,

Meadowvale and Port Credit will now be open until 9:00pm on Fridays from Labour Day to Canada Day.

- L. Reed informed the Board about a study focused on the mental health consequences and emotional labour impact of COVID-19 stressors in library work to which Mississauga Library has been invited to participate. Library staff will be selected at random to participate in a survey starting June 27<sup>th</sup>. The research is led by the McMaster Centre for Advanced Research on Mental Health and Society, and the McMaster Community Research Platform.
- The Board watched and enjoyed the latest Mississauga Library Youtube video entitled "Is the Library cool, again?". They were very complimentary of the quality with which the video was prepared and happy to note that according to today's youth (curators of cool), the library is "cool".
- S. Coles provided an update on the facility upgrades. Malton repairs have been completed and the branch has reopened. The new Customer Service Desk at Sheridan has also been completed. South Common Library redevelopment is on track and still on schedule to reopen in 2027.
- F. Raja presented the 2024 Impact Report which demonstrates the impact and value of the Mississauga Library through Social Return on Investment, metrics, and storytelling. The report is now posted on the Mississauga Library website on the About Us webpage. Plans are in development for opportunities to link to the report on social media as well. The Board feels this information needs to be sent out more broadly to Mississauga residents and requested that staff explore the possibility of printing out copies for distribution as well as putting it up on the City's digital screens.
